Requirements for Additional Classroom Teaching Certificate in ESOL (English to Speakers of Other Languages) through the Individual Evaluation Pathway: Additional Classroom Teaching Certificate (There is no certification code provided by CMSV for this certification)

Eligibility Requirements:

- Applicants must hold a valid NYS Teaching Certificate in a discipline other than TESOL

Curriculum Requirements:

- Content Core – Major or equivalent in One of the Liberal Arts & Sciences – 30 S H
- Course – EDUC 507: Linguistics Analysis
- Course – EDUC 508: Structure of American English
- Course – EDUC 722: Teaching ESL 1
- Course – EDUC 725: Teaching Across Content Areas – Methods of TESOL Pre-K to 12
- Course – EDUC 326: Teaching Literacy Skills Methods *Students may have fulfilled Teaching Literacy Skills Methods as part of primary teaching certificate (will not be offered within our series of courses)
- College Coursework – Language Other than English - 12 credits in a foreign/sign language/s documented on an undergraduate/graduate transcript or equivalent credit on CLEP or NYU Proficiency Tests (credits must be completed before you applying, but are not required to take courses)

Additional State Requirements:

- Content Specialty Test (CST) – ESOL
- Workshops – Child Abuse Identification – School Violence Intervention and Prevention – DASA – Fingerprint Clearance

Student taking individual courses must submit:
